#### PROPOSITION 28 BACKGROUND AND ACCEPTABLE USE

Nov, 2022: Voters passed Prop 28: The Arts and Music is Schools (AMS) Funding Guarantee and Accountability Act

New, ongoing program supporting arts instruction in schools beginning in 2023-2024

Local Education Agencies are required to ensure 80% of the AMS funds are expended to employe certificated or classified personnel to provide "arts education program instruction"

Remaining funds: training, supplies, materials, and arts educational partnerships

### ARTS EDUCATION PROGRAM INSTRUCTION

Definition

Includes(but not limited to)instruction and training, supplies, materials, and arts educational partnership programs for instruction in dance, media arts, music, theater, visual arts including folk art, painting, sculpture, photography,craft arts, creative expressions including graphic arts and design, computer coding, animation, music composition, ensembles, script writing, costume design, film and video

## PUSD FUNDING ALLOCATION: 1,872,481

### FUNDING AND REQUIREMENTS

The State Audit Guidelines and reporting requirements were completed in May, 2024

Carryover funding is allowed for up to three years

For 2024-2025: Almost all schools have hired staff meeting the Prop 28 requirements, all are expected to be hired before the start of the year

Sites will use carryover funds continuing with the 80/20% ratio

Boards are required to approve the 2023-2024 plan and the plan must be submitted to the State and posted on the district's website.
