Donation of Clarinet to Mr. Kevin Galloway from Rancho Medanos Junior High School:

I have been thinking about donating for a long time....but kept putting it off. I finally realized that there was more to this donation that needed to be brought out before finalizing everyone.

To me, this clarinet is a part of my overall "Why" in service and in as a professional educator. I needed to tell the story about this because it has informed how service in education occurred for me.

#### First:

- In beginning band at Cambridge Elementary in 6<sup>th</sup> grade until illness of Dad
   In 8<sup>th</sup> grade....not accepting study hall when I wanted to learn clarinet
- - o March to principal office....don't need study hall, need to learn the clarinet
- Mr. Maples agreed to supervise independent study during his prep
   In 9<sup>th</sup> grade.....deciding to make it into Jazz Band with Mr. Soder
- - In intermediate band
- Got a music tutor....former PHS music student
   10<sup>th</sup> grade....made it to 2<sup>nd</sup> chair first clarinet——on target and on schedule
  - Ygnacio Valley being built
  - Mr. Hansen.....put on YV Steering Committee
- Appealed to school board to remain at PHS....lost
   In 11<sup>th</sup> grade
- - o Mr. Hansen got me into independent study 11<sup>th</sup> grade English so that I didn't have to drop music....again...
  - o Mr. Soder let me practice with Pleasant Hill every Tuesday night and march with PHS every Friday night for football during my Junior year
  - o Mr. Maples, now a teacher at Ygnacio Valley guided me into District Honor Band and into East Bay Youth Orchestra
- All three of these educators helped keep my dream alive, being flexible where necessary to help me achieve my goals. I
  have remained friends over the years and even attended the 90<sup>th</sup> birthday party for Mr. Hansen. They all said that a key part of that was getting to know what my dream was. They said that they loved that I was vocal about what I wanted without being unpleasant. They also told me that knowing that they had made those things possible for me framed some of their fondest memories of their professional lives.
- I have had many chances to see the truth and the power of their approach.
  - Resident advisor taking student to the retreat
  - Working with students at Northgate when they had ornery teachers
  - Letting 19 year olds continue to get their diplomas when I was at Liberty
  - Setting up Independent Study for students in Acalanes district
  - o It is important to give students and staff permission and encouragement to let you know what they need
  - o While it is important to have consistent procedures, it is always true that there are exceptions to every rule and the procedures are for guidance, not blind obedience. It is better to do the right thing than to do things right.

#### 7. Information / Reports / Discussion

#### 7.01 Presentation - Early Literacy Program Update (Ms. Velasco)

Ms. Velasco introduced the Early Literacy coaches and together the team presented the Early Literacy Update. Ms. Velasco shared student data comparing student reading scores from when the district started using the DIBELS process to current reading scores, looking at each grade level. Ms. Velasco pointed out that because of this work, our district is ahead of the reading crisis happening throughout the United States. Coaches shared their processes for working with students and staff to implement the program.

Mr. Smith asked about the involvement of the parents.

Ms. Maxwell gave examples of different tools and ideas shared with families to use at home.

Mr. Smith asked what we do for families that don't come to meetings.

Ms. Velasco clarified that all reading data goes home to families and that families look forward to the receiving the new data.

Mr. Kelly Jacobs, 3rd grade teacher at Willow Cove Elementary School shared some of the positive things that have come from

working with his sites DIBELS coach.

- Mr. Arenivar asked about the work being done at the junior high levels.
- Ms. Velasco shared a few examples of the good work being done at the secondary level.
- Dr. Schulze thanked the Early Literacy coaches for all their hard work and dedication.

#### 7.02 PHS Varsity Girls Basketball - Del Mar High School Holiday Tournament December 27-30, 2019 (Mr. Strom)

Mr. Strom presented the request for the PHS Varsity Girls Basketball team to attend the Del Mar High School Holiday Tournament as well as some upcoming sports events.

### 7.03 Agreement for Clinical Affiliation between Windsor Manor, Rehabilitation Center of Concord and Pittsburg Adult Education Center for the 2019-2020 School Year (Mr. Lockwood)

Mr. Lockwood presented the item to the board for approval.

Mr. Woolridge asked about the different facilities being used in the Certified Nursing Assistant (CNA) program.

Mr. Lockwood shared the Adult Daily Living (ADL) skills experienced at each of the three facilities provides excellent practice for our students.

### 7.04 Memorandum of Understanding between John Muir Health Program Internships and Pittsburg Unified School District (Mr. Molina)

Ms. Sasser presented this Memorandum of Understanding with John Muir Health's Internship Program.

Mr. Arenivar asked about the work our students will be doing as well as when our students will be attending this program.

Ms. Sasser clarified the program would be a lot of observation and a great experience for our students.

Dr. Canciamilla suggested the district consider counting the hours as Community Service, and perhaps students could post a video on Pittsburg Pride, encouraging other students to participate.
