7.02 Student Board Member Comments (Ms. Gonzales)

Ms. Gonzales - Summary of CSBA Conference – 2nd CSBA Annual Conference:

- Presentation on The Protect Program, educating students on sex trafficking starting in the 5th grade and every 2 years, learning new lessons every two years. It was very eye opening and important. In California, sex trafficking is very high.

Former President Smith and I were on that panel along with Napa County Office of Education and Compton on the work each of our districts have done on narrowing the opportunity gaps, specifically around African American Students. When we go to these conferences, we learn and present. Thank you to the Board and our Student Board Member for representing us so well.

7.04 Board Member Comments (Trustees)

Arenivar - None

Dr. Canciamilla - Good job to Alexa Gonzales. At the last board meeting, I donated my clarinet to Rancho Medanos. I spoke on the role that played for me. After that, Mr. Kevin Galloway wanted me to come by the school. The students assembled and gave a convert. When I donated my clarinet, I gave my music as well. The band framed the music and hung it up in the band room.

Over Thanksgiving vacation, I was at the high school, helping with college applications. After each application is finished, they ring a gong and cheer. That was special to see.

Woolridge – Myself, Dr. Schulze, Ms. Ton, and Ms. Saucedo-Flemming from MLKJJHS attended a workshop on Full and Fair Funding. We decided to do an action group where we would create a campaign in our district, in support of what the county is doing. We had our first meeting.

 - We also talked about dignitaries coming down to tour during that week. Create a post card for students to complete, creating a lesson plan.

At the next board meeting, there will be a Resolution where we will be naming that action.

Curriculum Subcommittee - Thank you to Mr. Molina, Ms. Chen, Ms. Pettric, and Ms. Frazier-Myers, about the various policies and options for the PE Waiver.

When the Black College tour people came, I didn't keep a secret about sponsoring kids. I am sponsoring four kids. Thank you to Mr. Miller for sponsoring as well. It means a lot.

I have been talking to a mentor and I have a slogan about life now... "Productively busy". Instead of being in everything, I want to be productive, so I have decided to drop from the Delegate Assembly. I feel I could do more here on this Board.

Mr. Smith - Dr. Schulze talked about the panel we were on at CSBA. The student board member did a great job.

I would like to talk about a couple sessions, there is one on English Learners Roadmap, which was good and LCFF - Roles and Responsibilities of the Board Members, but I will email the board about those sessions.

Dr. Canciamilla – One more thing, there is an app now for the conference. We could turn in the attachments into the district office so if people are curious, they would have access to them.

Mr. Miller – Our 2nd grade class at Los Medanos Elementary are on national television and what they are doing is 'truth hurts', and I am very proud of that.

Our band has also gone viral with "I've got five on it".

The PLN Panel the district presented on Saturday morning, which shines a light on our District. Who are we and where are we getting these great ideas.

I am appreciative to the board for all they have done and the conference for all I have learned.

8. Information / Reports / Discussion

8.01 Presentation - Report of the Bond Sales and Refunding of Bonds (Mr. Haria)

Dr. Schulze – We have recently sold and refinanced some of our bonds, and Mr. Dave Olson will update us on those sales.

Mr. Olson - Congratulations. Tomorrow morning you will receive \$32mm to continue your facility improvement program. \$30mm will go to long term facility improvement. \$2mm will go to technology programs. Between November and now, we worked on a pacing for the program and worked on a strategy. We made presentation to the citizen' bond oversight committee, the facilities subcommittee of the board and communicated with the county. We want to be transparent bond program in the state.

Review of bigger objectives of the program that we want to provide: Pittsburg USD students with facilities that meet the District's educational standards and reflect community desires. We want it to be affordable and fair.

Review of challenges: The District has a relatively small tax base for the number of students we serve, and high standards for its facilities. The tax base has gotten very tight. We have a somewhat complicated bond program. We will be recommending a 3rd sale two years from now. The District is currently facing financial challenges.

Highlights: The sale generated proceeds at above the target level. The refunding saved the voters upward of \$10mm. Moody's rated the District bonds at Aa3.

Interest rates have declined over 10 years, but increased over a short term.

We need to spend this money in the next 3 years and spend it on what the voters voted on.

News to share: The firm I was working with decided to no longer serve the California schools, and my team and I are now with Backstrom McCarley Berry & Co., LLC

Savings on the refunding bonds: In the selling of our bonds, it will save the tax payers \$41mm over 30 years, \$10mm of which I talked about.

Mr. Woolridge - I hear about the savings, but where is that posted on the web site.

Dr. Schulze - That is great feedback for us to have our Business Services Department to post that on the web site and pull highlights out of that.

Mr. Smith – We should advertise what we are doing in the community.

Mr. Miller – Maybe you could present to the subcommittee.

Dr. Canciamilla – When Alexa and I were at CSBA, there was a session talking about a new requirement on our websites to have information 1 click away. Transparency is becoming more and more important.

Mr. Smith – Looking ahead, we are selling bonds in 2021. We haven't seen a recession in 10 years, so how does that effect when we go out to sell and we are in a recession during that time?

Mr. Olson - Tax base growth will be key and the level of the interest rate. We are counting on 4% growth. In terms of interest rates, they are generally lower during a recession.

In closing, I appreciate the chance to present to the subcommittee.

8.02 Overnight Field Trip - Pittsburg High Puente students to visit Southern California Colleges on March 4 - 6, 2020 (Mr. Whitmire)

Principal Whitmire presented on the field trip. This is an annual trip. Due to the number of students who want to attend, we are splitting it in two trips. They are visiting 4-5 universities.

8.03 Overnight Field Trip - Pittsburg High Puente students to visit Southern California Colleges on February 26-28, 2020 (Mr. Whitmire)

8.04 PE Waivers for Junior and Seniors at Pittsburg High School (Mr. Whitmire)

Principal Whitmire – We are bringing the PE Waivers for the juniors and seniors. We have gone through this process to look at opportunities for students to earn their PE credit. All students have passed 9th grade PE. This is primarily for those students who could not take that 2nd year of PE, due to their schedules. The counselors met with them and submitted necessary paperwork.

Mr. Woolridge to Mr. Molina - I thought when we were rolling out the PE Waivers from the FPM information, we were going to phase out a certain group. Is that after this group?

Mr. Molina - Currently, all of our 9th graders are taking PE. We wrote to FPM last May and they said they understand we made promises to students and had academic plans already written up. The 9th graders will have to take PE. Last year, we waived the seniors and some of the juniors. This is the remainder of the students. Might there be one or two more that were overlooked, there could be those that qualify under the previous waiver.

Mr. Woolridge – Sophomores, are they grandfathered into the old process, or the FPM process?

Mr. Molina – The old process, if they don't have room in their schedules.

Mr. Smith - The new PE exemption process...is that documented? Can that be included when it comes for Action?

Mr. Molina - We can attach the process.

Mr. Smith – It would be easy to have it in BoardDocs and have the community and parents access it via BoardDocs.

Mr. Miller - Will this resolve our PE Waiver issue?

Mr. Molina – We will be bringing processes to the Board for group, Marching Band for instance. We talked about that in the curriculum subcommittee.

Dr. Canciamilla - We had Alexa there as well and she represented the bands interest, so we made sure everyone was involved on this end. The curriculum subcommittee is going to bring forward a recommendation under Information in the near future.

8.05 Presentation: MOU with Sandy Hook Promise (Mr. Alegria)

Mr. Alegria presented on the Sandy Hook Promise.

This evening we are bringing forward an MOU with Sandy Hook Promise. It is a partnership between the Sandy Hook Promise, the school district and the Pittsburg Police Department.

The tool they bring is an anonymous reporting system. Sandy Hook parents got together after the tragedy and prevent

gun violence before it happens. How do we identify and intervene before students hurt others and/or themselves. This is being done at no cost to the District.

The Say Something Reporting System is an application (app). We know from previous activity that 80% of shooters told someone. This is a tool for students to report what they heard. This will report it to the police department as well.

Step 1: submit a tip

Step 2: Tip received and triaged – it will be assigned as non or life threatening tip

Step 3: School and/or law enforcement assess and intervene, as needed.

This coincides with our overall safety plan. A.L.I.C.E. is our plan. Sandy Hook is our prevention tool.

Mr. Smith - Thank you for the work you are doing.

What is the turnaround time of the submission via the app?

Mr. Alegria - 2 - 5 minutes, depending on life threatening and non-threatening.

Is their confirmation of the tip? Immediate help would be 911.

Mr. Alegria - One thing Sandy Hook will do is to come to our sites and talk about the program and how to recognize the signs.

Mr. Arenivar - Will all students have this?

Mr. Alegria - Once we launch, we will push each for every student and staff member to have the app.

Dr. Canciamilla - When you get access to the app, can you come and demonstrate it for us?

Mr. Alegria – Yes. And we would launch this specifically for the secondary school sites.

Mr. Woolridge – What is the number of people who can use the app at one time?

Mr. Alegria – Sandy Hook manages the call center. This is a nationwide program. They are able to manage large volume.

Ms. Gonzales – How does Say Something work? It says embed in school clubs.

Mr. Alegria - We would look at creating a club at the school sites, or embed into one of the leadership clubs. There is a program where Sandy Hook does an entire week. We will be looking at that when partnering with Sandy Hook.

Ms. Gonzales - Since its anonymous, do they know it's Pittsburg?

Mr. Alegria - The student would select the school.

Mr. Smith - Is location turned on?

Mr. Alegria - It shouldn't be.

Mr. Miller - How did you hear of it?

Mr. Alegria – We had a meeting with Contra Costa. All Districts were given the option to partner with Sandy Hook.

Personally, I worked with Sandy Hook with my previous district. The main focus should be prevention. In working with

Dr. Catalde, he has really worked hard on mental health.

Ms. Gonzales - At the high school, mental health is a big thing...but our providers cannot over help. Can you call and/or text through this app and talk to a person?

Mr. Alegria – Yes, students will be able to do that?

8.06 2019-2020 PEA Sunshine Proposal from Pittsburg Education Association (PEA) to PUSD (Ms. Tamondong-Bradley)

Ms. Tamondong-Bradley brought forward PEA's Sunshined Articles, Article 6 – Hours of Employment, 12 – Employee Benefits, 13 - Salary, 17 – Summer School. Negotiations are starting in January 2020.

Speaker Card - Andrea McKinney, PEA Bargaining Chair. Thank you for the negotiation dates, and your continued work you have done in the past. Also, I was listening to the Sandy Hook Promise presentation, and I look forward to the great program afforded to our students at Black Diamond High School as well.

8.07 Memorandum of Understanding between Pittsburg Education Association (PEA) and Pittsburg Unified School District (PUSD) for Teacher Induction Program (Ms. Tamondong-Bradley)

Ms. Tamondong-Bradley presented on this board item. This MOU was presented to PEA, covering a stipend fee for any teacher taking on more than 15 teachers. If more than 15 teacher, we are paying \$2,000 per student.

Mr. Woolridge – This is the same as BTSA and I thought the county was taking that on?

Dr. Schulze – This is taking the place of BTSA and you may recall the county did not have enough TIP Mentors to support all districts.

8.08 Memorandum of Understanding between Contra Costa County Office of Education and Pittsburg Unified School District (Dr. Frazier-Myers)

Mr. Molina presented on this board item.

Mr. Woolridge - In a Friday Letter, can we get the districts responsibility on J., where it talks about the graduation requirement. And secondly, it says this MOU begins October 1, 2019. Have we been doing this or did it come to us late? Dr. Schulze - the CCCOE has always provided services for foster youth. The state has now directed it to the CCCOE. What this does is outlines their responsibility and the Districts responsibility. This is a new MOU, as it has not been in place before.

8.09 Updated Board Policies (Mr. Molina)

Mr. Molina presented on this board item.

We have a number of board policies as part of our Federal Program Monitoring (FPM). They will be coming to audit. Since there are so many, I decided to take it to the Curriculum Subcommittee and present as a spread sheet to make it easy for us and the public. For clarity and transparency, I wanted to state that this was reviewed at the Curriculum Subcommittee.

Mr. Woolridge - I had a couple changes: BP 1340 – The District may charge for copies or public records. The cost should be placed by Superintendent, or designee. I think we need to change that to the actual cost.

Dr. Canciamilla - We went through all 13 of these board policies, and gave on your behalf our recommendations, but one of the things that was asked of us was to clarify with the rest of our board members before they are brought for Action. The one thing I brought up was the samples from CSBA, where they have 'Notes' in there. One of the things in the workshop was to say that it was okay for Boards to leave the notes in there, to give information to the public as they are looking at board polices. What we have said in the Subcommittee was to say, it's okay to leave the Notes in there. As a Board, we need to give direction to staff to do.

Mr. Molina - There are two board policies where you will need to vote on an Option, 5022 – Student and Family Privacy Rights. There are two options, and as a Curriculum Subcommittee, we are recommending Option 1...we will not give or disclose information for marketing purposes.

Dr. Canciamilla – Some of the Notes can give you more clarity.

Ms. Gonzales – I move for Option 1. Board – agree.

Mr. Molina - BP 5125.1 - We have to take Option 1 - It is for use by District that received fund under Elementary and Secondary Education Act (ESEA).

Mr. Molina – For BP 1340, Mr. Woolridge is recommending, "The charge shall be based on actual cost of duplication." The sentence will end there.

Mr. Miller – I feel more comfortable keeping it.

Mr. Smith - I am fine leaving as is written.

Dr. Canciamilla – The other part is when leaving at actual cost, it could include employee time. And in the Administrative Regs (AR), you could go into more detail. That is the how in doing business. We wouldn't want that in Board Policies, because that could change over time.

Mr. Woolridge – That would simply the board policies.

Dr. Canciamilla – Staff needs a signal from us on what to prepare for Action.

Mr. Smith – Leave as is written

Mr. Miller - As is written.

Mr. Arenivar - As written.

Mr. Woolridge - BP 5145.11 - Questioning And Apprehension By Law Enforcement...

Dr. Canciamilla – We should temporarily number the pages, so we can reference it.

Mr. Woolridge -2^{nd} page, last paragraph - "Except in cases of child abuse or neglect, he principal or designee shall attempt to notify the student's parent/guardian as soon as practicable after the law enforcement officer has interviewed the student on school premises." The word 'after' is an issue for me. As a parent/guardian, I should be able to be in the room.

Dr. Schulze – This is not applying to our School Resource Officers and day to day. Technically, you could make an attempt to call the parent/guardian beforehand. The board policy helps to say, I understand, I need to follow board policy and attempt to contact the parent.

Dr. Canciamilla – To echo De'Shawn, it would be nice to have it in there if not going against a new law I wasn't aware of.

Mr. Smith - Agree.

Mr. Miller – Agree.

Mr. Woolridge – I am just asking for the attempt.

Mr. Molina read the language the board agreed upon to change 'after' to 'before'.

Dr. Canciamilla - BP 1100 Community Relations – Page 5, Comprehensive Communication Plan – "The Superintendent or designee shall develop a written communications plan which establishes priorities for proactive community outreach to build support for district programs and issues. The plan shall identify specific communications goals aligned with the district's vision and goals for student learning. For each communications goal, the plan shall identify key messages, individuals or groups that can help the district achieve its goal, strategies tailored to each target audience, timelines, persons responsible for each activity, and budget implications."

Even though we have an LCAP and Safety Plan, they have to be seamless. It's really important that we don't let it go with what the sample says without looking at the AR's. I said that strongly at Curriculum Subcommittee.

Mr. Molina – The following optional section may be revised. There are a number of things we do as a district to communicate. I would like to know if you would like to keep this.

Dr. Canciamilla – I would. We would need to revise our web site.

Dr. Canciamilla – Isn't Step and Column a little more than 1.75%?

Mr. Haria – It all depends on the salary schedules and what has been updated year to year.

Dr. Canciamilla – When schedules get higher?

Mr. Haria – It depends on the scale.

Dr. Schulze – Our salary schedules are not squared.

Mr. Haria – Revenue \$147mm, Expenditures \$157mm, Estimated Ending Balance \$10.7mm. Adopted Budget, First Interim, Variance –

A Special Ed. one-time Preschool grant B Carry-over of MAA and safety dollars C Carry-over from unspent title funds from 18/19 D Mostly the K12 strong workforce grant - a new grant E Carry-over of Title I, Title II, Title III, Restricted lottery and Medi-Cal dollars F LCAP contracts \$347K Donations \$60K Maintenance \$202K Low performing block grant \$160K Special Ed. \$119K Federal programs \$314K G Carry-over of Prop 39 \$206K

This basically shows what we adopted in June and what our First Interim was.

Mr. Smith – The carry over dollars have to stay where they were carried over?

Mr. Haria - Yes.

Dr. Schulze – For instance, our book adoption was paid this year and not last year.

Mr. Haria – Salaries and Benefits comprise approximately 87% of the District's unrestricted budget and 78% of the total General Fund budget (which is Unrestricted and Restricted combined).

Dr. Canciamilla – If a majority of our money is in restricted, I think that is an important piece of information.

Dr. Schulze – We can put that in a Friday Letter.

Mr. Haria – Enrollment projections from Decision Insight. When we spoke with Decision Insight, we had to look at Making Waves and they are no longer in the projections for the 2020-2021 and 2021-2022 school years.

Mr. Woolridge – Are these conservative or moderate numbers.

Mr. Haria – Conservative. Multi-Year Projections (MYP). We will make adjustments as the Governor's Budget comes out.

Dr. Canciamilla – The declining enrollment...it would be helpful to know where we are losing the kids. Maybe put that in a Friday Letter.

Mr. Haria – We will look at that in February and for presentation in June.

Expenditure Assumptions: 1.75% increase, and there was a change in STRS by .1%. STRS and PERS is increasing every year.

Mr. Woolridge – When this comes back for Action, what the 0.3% looks like in dollars.

Mr. Haria – Page 13, Net Increase (Decrease), you will see we are projecting deficit spending. If we don't shift things, which is the effect it will have. 2020-2021, -\$535K. At the end of the 3rd year, we are looking at -\$10mm. We need to make \$15.9mm in reductions (over 2-year period).

Dr. Canciamilla – If we cut earlier, it will have less negative impact?

Mr. Haria – Governors Budget, Bargaining, all make a difference. With our negative fund balance over the two years, we are recommending certifying as 'Qualified'.
