SECTION 31 12 17 SEALING ASPHALT PAVING

The General Conditions, Supplementary Conditions and Division1 General Requirements are hereby made a part of this Section as fully as if repeated herein.

PART 1 - GENERAL

1.01 DESCRIPTION:

- A. Contractor is to supply all labor, material and equipment necessary to perform the work specified herein.
- B. The Contractor will treat vegetation growing in cracks with a suitable herbicide two weeks before starting work.
- C. No work is to be conducted during rainfall. Work is to be conducted only when ambient temperature is above 50 degrees Fahrenheit.

PART 2 - PRODUCTS

2.01 MATERIALS:

Α.	DOCAL 1002, SS-1h	asphalt emulsion

B. DOCAL 1105 asphalt sealer

C. DOCAL 1100 "VISCOLASTIC" crack filler

D. Sand plaster sand, all passing #30 mesh

E. Water fresh and potable

PART 3 - EXECUTION

3.01 SURFACE PREPARATION:

- A. The entire area must be thoroughly cleaned. Peripherally encroaching vegetation as well as remaining vegetation in cracks to be removed. Cleaning is to be performed by sweeping, flushing, blowing with compressed air, power washing or any other means necessary to remove all loose particles of paving, dirt and any other extraneous matter from cracks and surface.
- B. Fill cracks wider than 1/8" with DOCAL 1100, or equal as approved by District.

3.02 FILLING LOW SPOTS:

- A. After crack filler has cured, thoroughly wash down the entire area with water using enough to indicate low spots.
- B. Mark all low spots. The surface is to be examined by the inspector to assure that all low spots have been identified. After Inspector's examination, broom off excess water.

- C. To each area marked, apply a tack coat of DOCAL 1002, SS-1h consisting of one (1) part emulsion to five (5) parts water, by volume. Apply at the rate of three (3) gallons per one hundred (100) square feet. As the tack coat dries and begins to brown, sweep-spread any black areas that indicate low spots to facilitate drying.
- D. After the tack coat is thoroughly dry, to each low area apply sufficient DOCAL 1105 and sand to bring low areas level. Mixture shall be as follows:

1 gal. DOCAL 1105
3 lbs. 30 mesh sand
1 qt. DOCAL 1002, SS-1h
Minimum water to allow semi-fluid mixture

E. Allow to dry for minimum 24 hours.

3.03 PRIMING:

A. Over the entire area to be sealed, including leveled areas, apply a prime coat (tack coat) of the following, by volume:

One (1) part DOCAL 1002, SS-1h Five (5) parts water

Rate of application: Approximately 3 gal/100 sq.ft. Broom out puddles

Drying time: Primed area shall be allowed to dry for minimum of 24 hours before further applications.

3.04 SANDED ASPHALT EMULSION COURSE:

A. After the entire areas has been primed and allowed to dry for 24 hours, two or more squeegee coats of Sanded Asphalt Emulsion shall be applied of the following:

Three (3) Pounds 30 mesh sand
One (1) Ga. DOCAL 1105
One (1) Quart DOCAL 1002, SS-1h
Enough water to obtain a semi-fluid consistency.
Rate of application: Approximately 6.85 gal/100 sq.ft.

B. Rolling – After the required coats of Sanded Asphalt Emulsion have been applied, the entire area is to be rolled with a lighter roller of 3 to 5 tons in weight. Rolling may be started as soon as material has sufficiently dried to prevent sticking to the roller.

3.05 FINISH ASPHALT EMULSION COURSE:

A. After the Sanded Asphalt Emulsion Course has been properly rolled to a smooth and even surface, two or more squeegee coats of Finish Asphalt Emulsion is to be applied of the following:

One (1) Gal. DOCAL 1105
Enough water to make a free-flowing consistency

Note: The absolute maximum water that may be added must not exceed one part water to two parts Asphalt Emulsion.

- B. Mixing: The entire contents of each drum of Asphalt Emulsion is to be emptied into a mortar box or plaster mixer and mixed to a free-flowing consistency. Water added must be held to a minimum and must never exceed the limits as indicated above.
- C. Application: Asphalt Emulsion is to be applied to the entire area by pouring from a can or wheeled container in continuous parallel lines and spread immediately with rubber squeegees or long-handled hair brooms. The spread is to be pulled toward the operator and held at an angle to the line of spread (as a blade on a road grader) to avoid an overflow or "spill" on its forward edge away from the operator. After each coat of Asphalt Emulsion has dried, ridges are to be removed with a scraper.
- D. Application Rate: <u>Two or more</u> coats of Asphalt Emulsion is to be applied using a minimum of 2 gal/100 sq.ft. ¹ total, of <u>UNDILUTED</u> material with the absolute minimum water added.
- E. Drying Time: Sufficient time is to be allowed between coats to prevent successive coats from "picking up" preceding coats.
- F. Rolling: After the final coat of Asphalt Emulsion has thoroughly dried, the entire area must be uniformly rolled leaving no ridges or roller indentations. The roller must weigh from 1,500 lbs., to 5 tons. Rollers must not be left standing on sealed areas at any time.

3.06 TRAFFIC:

A. It is the responsibility of the Contractor to keep all traffic off the entire sealed area for a minimum of four (4) days after finished surface has dried completely.

3.07 MATERIALS AUDIT:


A. The Inspector will audit whether the proper amount of packaged material is being applied by making an "empty container count" and comparing with the chart below.


