7.01 Presentation: Pittsburg Unified School District, General Obligation Bonds, Election of 2014, Series C (2018), Measure N (Mr. Scott and Dr. Schimmel)

Mr. Scott provided some background on the bonds and briefly explained the process involved in selling bonds. The recent meeting with the county resulted in an increased rating for our district.

- Dr. Schimmel Our Superintendent, along with the team, was impressive and the stability of this team was part of the reason for our bond rating increase. Dr. Schimmel provided some explanation about the financial impact, the significance of the increase and the savings to the Pittsburg community.
- Mr. Woolridge is there a way we can get this information out so the community can see it.
- Dr. Schulze we have put out the press release and newspaper article in the East Bay Times and a page on our web site with links to this information, and we can put it on Facebook.
- Dr. Canciamilla shared some of the information she quickly learned when she became a board member about assessed property value that affects the Pittsburg community vs some of the surrounding communities. It would be good to find a way to let the community know and better understand.
- Dr. Schimmel The bond is the same in each community, but the assessed value is not the same in each community.
- Mr. Miller What funding is covering the Parkside rebuild?
- Mr. Smith Is the bond oversight committee still fully staffed.
- Mr. Scott Yes, the list is on the website.

Ms. Gonzales acknowledged Larry Oshodi in supporting Nelson Alegria in doing this presentation. Mr. Alegria provided the safety update explaining the objectives, various components of the site safety plans that will be coming to the board in the near future.
