6. Comments

6.01 Public Comments: Items Not on the Agenda There were no comments.

6.02 Student Board Member Comments (Ms. Elam)

- On January 12th students had a New Year's Dance, this is a new concept so the attendance was small, but everyone had a good time.
- Last Thursday the middle schools and elementary schools came together in the old gym and were engaged with some of the leadership students in a rally and other entertainment.
- We are preparing for the 8th grade open house on February 1st; seniors are helping with the presentations and students who received athletic scholarships will talk about that process.
- The Link Crew is doing a matinee tomorrow for all the freshman students to include 4 movies, free popcorn and free movies for freshman.
- Leadership is planning a lot of spirited activities for spirit week and possibly another dance or a carnival since there are extra funds in the club budget.
- Today we had one fight on campus, but overall things are good
- Parent-teacher conferences were held last week

6.03 Superintendent Comments (Dr. Schulze)

We had a couple of activities where our students were involved in planning and performing with the community for the Martin Luther King Jr. celebration. A few of the highlights: The NAACP Breakfast was held at our own MLK Jr., Junior High School where Vice President Smith did the opening remarks; the male step team from MLK Jr., Junior High performed at the event – which was a newly formed team; and later that afternoon was the celebration organized by Mr. Greg Osorio where our students competed in the Spoken Word Contest. The top 6 winners performed that day and will come to perform for the Board and community at a future date. I want to thank the student performers, the staff, the judges, and everyone for their collaborative participation. Also 2 of our student officers – 1 from Latinos Unidos, and 1 from the Black Student Union, co-hosted this community event with our students.

We also had a group performance at the Creative Arts Building entitled "At the Table with Dr. Martin Luther King, Jr." One of our teachers, Ms. Ann Miani, has a nephew who is part of a performance group that does a multi-media interactive production around the life of Dr. King. Our students from Stoneman Elementary and all of our 8th grade students were able to enjoy the performance. Thank you to our Bus Drivers and the Transportation Department for getting our students to this event, thanks to our leadership students for their time and Mr. Molina and his staff for coordinating the event.

I had the honor of being asked by ACSA to lead a session for aspiring Superintendents, and was able to facilitate the training this past Saturday. The topic was on Ethical and Reflective Leadership. We worked through some good scenarios and had great discussions. I am grateful to ACSA for that opportunity.

We will soon be kicking off our LCAP community input sessions and will start with a community budget workshop on February 12th. We invite anyone to who is interested in learning more about how things work with school district budgets.

6.04 Board Member Comments (Trustees)

Mr. Smith - Some key highlights from the recent 2x2 meeting: to-date the Police Officers have done 125 visits to our school sites this year. The Sister City visit is being planned for late August, and November marks the 20th year anniversary of the program. Pittsburg Police and PUSD staff have visited all the sites to improve safety in getting to/from the schools. With the new BART coming into town - they are surveying the parking situation and determining how it will affect the area around PHS. Information was shared about Marina Vista and how the turf field is cared for. I participated as a Judge, along with Mr. Miller, for the Spoken Word Contest. Their theme was "What's Good About Pittsburg?" I also attended the NAACP breakfast and the MLK Jr. celebration at the CAB.

Mr. Miller – I attended the 2x2 with the City as mentioned by Mr. Smith. I also attended the NAACP breakfast and want to thank Mr. Palacios who cooked a meal for that event. Even though he does not live here, he always strongly supports this community.

Dr. Canciamilla – I just returned from Rome and had the privilege of watching our students perform. It was wonderful to see the excitement on their faces in this historic place and marching on the cobblestone streets where the crowds loved them. While there I visited Isola, you may recall a group of them came to Pittsburg last year –and they were truly proud of the Pittsburg band for their visit to Rome. "Shout out to Nicky" for the updates on our Facebook page, it is always good to stay in touch by her updates. It's also nice to be home.

7. Information / Reports / Discussion

Mr. Whitmire – In recent years the number of students applying and attending colleges outside of the Bay Area has increased. The Puente Staff will take the 11th grade Puente juniors to visit colleges starting in the Central Valley and ending in Southern California. This trip exposes our students to other colleges and encourages them to apply statewide during their senior year.

7.02 Campus Supervision and Student Connectedness on PHS Campus (Mr. Whitmire)

Mr. Whitmire – addressed the Board to speak on student engagement and the culture of safety at Pittsburg High School. There is a positive climate in the area of the new building and Mr. Alfaro is doing a great job on that campus. One of the goals is to involve as many students as possible in activities. When students are positively engaged they are less likely to get into wrong activities. Some of the positives include - community services functions, campus clubs, the Every 15 Minutes exercise, and lunchtime activities. Currently there are 44 active clubs on campus with approximately 300-400 students regularly participating. Mr. Whitmire provided a brief overview of the discipline and safety activities that are present on campus.

Mr. Woolridge - It would be good to have a letter sent to the parents reminding them about the safety dog being on campus.

Dr. Canciamilla - Years ago the board made a conscience decision to maintain only 1 high school, with the concept that we might need to do some things to keep the population from growing too large. It would be good to know the proportion of students to leadership. As we move forward it may be critical to know the percentage of students who are connected with clubs and activities.

Mr. Smith - It would be good to know the number of students who are not involved in anything and why.

Dr. Canciamilla - It also would be good to have the walkie-talkies tuned into the location of each individual who uses them.

7.03 Update on Safety Procedures and Trainings (Mr. Ahonen, Ms. Gonzales, Matt Belasco)

Ms. Gonzales reported that she serves as the VP for Contra Costa County School Insurance Group (CCCSIG), and their reports show that PUSD injury and incident rates have gone down along with the cost of claims. Safety for our students and for staff is a high priority. In fact, this year our district received incentive funds because of our positive safety record and the funds are put back into the safety program for use. Mr. Belasco noted that the Health and Safety Committee has collaborated with PEA on fixing some deficiencies quickly and have put plans into place to address other issues. Two recent locations are Adult Ed, Willow Cove where we staff worked together to resolve problems. Mr. Ahonen - one of his many responsibilities is to increase response readiness, and to plan and prepare for emergency crises situations. Our schools are responsible for conducting drills each month, as a district we annually participate in the Great California Shake-Out, we send employees to response training, we do various exercises for catastrophic events to see how people respond in different emergencies, and we work with the City of Pittsburg Operations Centers to stay connected on these types of incidents. Ms. Maggie Gonzales, Campus Resource Assistant, and Brian Scott, School Resource Officer - described some of the recent training that they received. They train monthly at the sites and in various locations to stay on top any active shooter concerns, and they are conducting the A.L.I.C.E. training with site staff.

Speaker: Chris Coan – as the PEA Grievance Chair I have started a movement for safety. The School Site Safety Plan is 172 pages of information, but each site received the only 4 pages that contained their specific job assignment. She gave examples from the responsibilities that would be given to staff in the case of emergency and described an emergency scenario to the Board. "The written instructions were given to staff and they do not know what to do".

Speaker: Willie Mims – East County NAACP and Black Political Association, the scenario that was read needs to also have a follow-up plan. In terms of the active shooter, he was told that an employee was being shot-at and the employee ran onto the PHS campus. He expressed concerned that there was no lock down on that particular day. The Plan does not say what to do in the scenario of an active shooter, and there are no examples given.

Dr. Schulze - Clarified that there was no active shooter situation at PHS. The district works in partnership with the Pittsburg Police Department and the Chief of Police was our source of contact on the incident that took place. But there was no active shooter situation at Pittsburg High School.

7.04 Lead Sampling Results (Mr. Belasco)

Mr. Belasco – Sometime around October, 2017 Mr. Palacios and I had a discussion about the need for lead sampling at our sites to make sure the water was safe for our students and staff. The City of Pittsburg is responsible for the local water and we have partnered with them to develop a program is for all K-12 schools along with the Adult Ed site. We are pleased to report that there were no concern levels of lead found in any of the school sites.

Dr. Schulze – thank you Mr. Smith for sending information to staff on how we could participate in some of free testing opportunities for testing, and thank you Mr. Palacios and Mr. Belasco who were already proactively looking into this area.

Mr. Palacios reviewed details of the Governor's January Budget message. This is the first step in the budget cycle for the next fiscal year. The next cycle is presentation of the 2nd Interim Report to be presented a few weeks. The issue of accountability will become more increasingly critical in the next few years as federal policy is going in a different direction than the state. California will soon begin to feel the impact of changes made at the federal level as federal policy and slow growth put pressure on programs for California. The LCAP will be front and center as we move forward.

7.06 Quarterly Williams Uniform Complaint Report (Oct. - Dec. 2017) (Mr. Molina)

Mr. Molina - The District received no Williams Uniform Complaints during the last quarter of 2017, in the defined areas of Textbooks/Instructional Materials, Teacher Vacancy or Miss-assignments, and Facility Conditions.

Speaker: Willie Mims expressed that every year when the Williams Report is given there are no complaints. The instructors at the schools must be afraid to report the complaints. I hope that the staff knows what and how to lodge a complaint.

Mr. Palacios – Tonight's report is the last portion of the 2016-17 budget cycle. We have Sarah Fiehler from Christy White Accountancy Corporation will to speak on a change that will be made, and then the report will come back to the Board.

Ms. Fiehler – As part of the auditing standard, if circumstances arise after the issuance of the audit report, it is the responsibility of the Auditor to review those circumstances and take into account what effect those circumstances could have on the financial statement. We will work with management to identify any impact on the financial statements. The financial statement will then be revised, the audit report will be reissued and presented to the Board at a February meeting.

Dr. Schulze - this is specifically regarding an incident that occurred with our Adult Education budget and is still under investigation, so we are not able to speak directly to that issue. But, we can assure everyone that this will not result in cuts to staffing or programs at Adult Ed.

Dr. Canciamilla - As the report is being prepared to come back to the Board it would be good to have some additional information regarding those specific student body accounts at as part of the findings.
