#### 6. Comments

6.01 Public Comments: Items Not on the Agenda

Dr. Canciamilla stated that the Board can only listen to information brought forward during this time but cannot respond as the topic has to be on the agenda in order to be discussed.

Public Comment: David Vincent, Representative from the Sheet Metal Workers Union, Local 104, stated that he and his union are concerned with the process he believes was not followed for the HVAC bidding. He believes that the procedures followed did not meet the qualifications and state laws around the subject.

Public Comment: Jean MacDonald, teacher at Adult Education, asked for a moment of silence for Paul Shattswell and asked that the community keep him in their thoughts during this difficult time.

Public Comment: Tammy Carr, PEA President, thanked the Board for supporting the Shatswell family. She shared concern about the information that was shared during the LCAP meeting and the meeting's content. She also shared information about an upcoming rally that will take place in Sacramento to ask for an increase in educational funding.

#### 6.03 Superintendent Comments (Dr. Schulze)

Dr. Schulze thanked Ms. MacDonald for the moment of silence and thanked staff, students and community for their support. She shared that a lot of people are asking what they could do to help, anyone who would like to donate, Anthony Molina will collect donations and gifts and distribute to the family.

#### 6.04 Board Member Comments (Trustees)

Dr. Canciamilla shared that as a former Adult Education administrator, she salutes staff for the way that they have come together. She said that it is gratifying and heartwarming to see the support. At a time of sadness, she salutes everyone involved. She shared that the Parkside Groundbreaking ceremony occurred. Congratulated Maureen Mattson for being Teacher of the Year. She reminded everyone to wear crazy socks for Down Syndrome Awareness day the following day.

Mr. Miller expressed his support to the Adult School.

Mr. Smith shared that he attended the ACSA dinner to honor PUSD staff. He shared that HR held a Job Fair the previous Saturday. He also attended the Pittsburg Rotary brunch and the Parkside Groundbreaking ceremony.

#### 7. Information / Reports / Discussion

#### 7.01 Overnight Field Trip - Camp Concord in South Lake Tahoe on June 24 - June 28, 2019 (Ms. Barbee)

Ms. Barbee shared that students from the three junior high schools will attend a weeklong field trip. She announced that Camp Concord notified her that they will cover the cost for the field trip as well. Everyone is very excited and staff really enjoy the trip.

Dr. Schulze thanked Ms. Barbee for her enthusiasm and said that she knows how much she loves Camp Concord.

# 7.02 Field Trip - PHS Football and Cheer Trip to Wooster High School in Reno, NV. (Non-hotel stay) on September 7, 2019 (Mr. Strom)

Mr. Molina shared that the PHS Football and Cheer team will go to Wooster High School in Reno, Nevada. He explained that the students will leave early and return late the same day.

### 7.03 Out of State Travel for Pittsburg High School, teacher to attend the ASE Auto Instructor Training Conference in Frisco, Texas on July 22-25, 2019 (Mr. Whitmire)

Mr. Molina shared that a teacher will participate in the ASE Auto Instructor Training Conference in Texas and that is a part of the grant that we just put in and it is a necessity.

Dr. Canciamilla stated that she would like needs, goals and measurements when the item comes back for Action.

#### 7.04 PE Waivers for 19 seniors at Pittsburg High School 2018-2019 School Year (Mr. Whitmire)

Mr. Molina presented the information with support of Mr. Niaker, Vice Principal and Mrs. Fu, Counselor. He shared that there is a group of 19 seniors who will need PE waivers for this school year in order to graduate.

Mr. Woolridge asked if there is a process for obtaining a P.E. waiver and shared that parents have contacted him to complain about how they can't obtain a waiver for their student.

Mr. Molina shared that the District has been following the process per Ed. Code and the Board Policy. The process current process will be brought back as information for the next Board meeting. He shared that there is a difference between a permanent waiver and a temporary waiver as well. There was a Federal audit which made the District rethink the waiver process which will be discussed in the next Board meeting.

Mr. Woolridge mentioned that he knows of three students who had to enroll at Los Medanos College for credits.

Mr. Molina responded that with this approval, these students will be okay.

Dr Canciamilla stated that she does not want students to be caught up and affected. She requested that the information become accessible and suggested that the information be presented in the course catalogue.

Mr. Arenivar asked why students were not able to take P.E.

Mrs. Fu answered that the class did not fit in the student's schedule.

Mr. Molina clarified that students have a two year PE requirement, most students have completed one year but due to pathway classes filling up the students schedules, they are in need for one more year to be eligible to graduate.

Mr. Smith asked why the marching band isn't counted as a P.E. class.

Mr. Molina answered that there are state standards that are required for P.E. credits.

Dr. Canciamilla asked that the State findings be brought back.

Ms. Gonzales agreed with Mr. Smith regarding marching being counted towards P.E. as she knows that the class is very physical. She stated that she can show the activity on her phone.

Public Comment: Alexandra Gomez, PHS Student, expressed that she is a current junior and band member, she wanted to express her support for the P.E. waiver for PHS students. She shared a spreadsheet with data detailing the amount of exercise students complete during band practice.

Mr. Woolridge responded that the Board will not vote on the issue as it is up for information.

Mr. Smith commended the student for speaking about this and for bringing data as a backup. He stated that she did a great job expressing her concern.

The Board thanked her for speaking about the issue and commended her for doing a great job with the data she provided.

Dr. Schulze stated that she was impressed with the thoughtfulness on what the student presented.

7.05 2018-2019 CSEA Sunshine Proposal from Pittsburg Unified School District (PUSD) to California School Employees Association (CSEA) (Ms. Gonzales)

Ms. Gonzales shared that last week CSEA brought forward their articles and the District is now brining forward articles as well.

### 7.06 Memorandum of Understanding and Agreement with Contra Costa County Office of Education Teacher Induction Program (Ms. Chen)

Ms. Chen shared the yearly MOU for the Teacher Induction Program with Contra Costa County Office of Education. This will be to provide induction services for teachers who need to clear their credentials.

Dr. Canciamilla thanked the District for providing support for the teachers.

Public Comment: Tammy Carr, PEA President, expressed concern regarding the participants in this program.

# 7.07 Approve the use of Waterford Unified School District Piggyback bid for purchase of three (3) new school buses (Mr. Belasco)

Mr. Belasco presented a slideshow that provided information on why the District is in need to purchase three buses. He stated that three of the current buses will be obsolete as of January 1, 2020. Payments could be made for up to ten years.

Mr. Meindersee, Mechanic for the District, shared that the new buses will be in compliance with new laws as they will have seatbelts and features that will meet the new standards.

Mr. Woolridge expressed concerns on how the buses being replaced will be discarded and suggested that if possible, the District try to sell the busses.

Mr. Belasco responded that the District will auction the buses as they have done in the past. He assured Mr. Woolridge that the District has a procedure for how they try to gain funds for vehicles that will no longer be used.

Dr. Canciamilla expressed concern on the interest rates that will be accumulated during the ten year payment plan.

Mr. Belasco responded that the cost for interest rates will be around \$37k in interest in ten years.

The Board had clarifying questions regarding the features and timeline for the new buses. They asked about the lifespan of the rest of the buses in the District.

#### 7.08 New Administrative Regulation (AR) 3452 - Student Activity Funds (Ms. Mims)

Ms. Mims, Business Supervisor presented the new Administrative Regulation for Student Activity Funds to the Board. She spoke about the procedures that are in place and provided a manual for the Board to review. The District shares the same business software in which she offers trainings to staff that need assistance. Also talks about cash handling.

Mr. Arenivar mentioned that the manual will be a good step especially since the District always has findings on student funds during audits.

Mr. Woolridge said that he likes the manual and having been in Leadership during high school, he believes that the information should be shared with high school students.

Ms. Mims responded that students have been invited to trainings and all students clubs have been included.

Ms. Gonzales, Student Board Member, asked about the trainings offered and expressed concern as she was unaware of trainings and has been in leadership for the past two years

Mr. Smith asked that Ms. Mims make sure all student clubs are notified for the trainings.
