Happy New Year and I hope the second Semester goes great for all of you.

6.03 Superintendent Comments (Dr. Schulze)

Welcome back and happy 2020! Although we are in the year 2020, it might feel a little more retro because we are unfortunately in a situation where we are operating as we would say "back in the day". We have binders for this meeting as our internet is down. I want to thank everyone for your patience as we work through this. This is an unusual situation, the investigation is ongoing and as we get more information we will share it. We are unable to send or receive emails or access certain systems right now. Two of the things that are the most important that I would like to share is that at this time, we have no indication that personal information of our staff and students has been compromised, what this ransomware virus did, was to encrypt information and not steal it. The investigation is ongoing as the repair is ongoing. Second, we were able to have everything up and running for our schools for the teaching and learning to go on, it can go on without internet and it can go on without devices. I know that this is something that is unusual lately but I think it is a good reminder that every obstacle and challenge has a silver lining. It is a good reminder to be present and not be distracted and rely so much on technology. I am proud of our students and teachers for being able to get right back into school so the day to day teaching and learning will have a minimal impact. Food Services is up and running as well, it is mostly the operational side in the District. We will be posting and sending out messages with updates as soon as we receive them. We have a cyber security team working with another expert team and the FBI is involved as well. I would like to commend our own IT staff, Mr. Haria, Mr. Scott, Mr. Melodias and their entire team. They worked over the break. One of the best compliments you can hear is when an outside company comes in and they let you know how welcome they feel here and how everyone has been organized and welcoming as they go site by site getting repairs done. We will put out information out as soon as we have it. Thank you for your patience as we get through this.

6.04 Board Member Comments (Trustees)

Mr. Arenivar - I would like to apologize to the tech people.

Dr. Canciamilla commented and provided a document with the comments below: Issue of budget cuts

Background

- For some time I have been describing the level of underfunding that our state provides for education--that we would need to receive \$2,475 per student in additional funding to just reach the national
 average level of educational funding. This would result in an additional 27 million dollars for our
 district.
- With this, we could provide deeply needed resources for our students and our staff. Resources that
 were once available to the students in the state of California. These could include elementary
 counselors, nurses at all the schools, and other supports that we do not have at this time that are
 needed.
- Given that we currently do NOT have supports we need, it is doubly distressing that we are also faced
 with the need to make deep cuts within our currently insufficient funding. We have several reasons
 that have caused this, not the least of which is the increased retirement costs that have been shifted to
 the districts by the state to pay from the insufficient Prop 98 funding level.
- It is a given that any cuts that we make are going to hurt our students and our staff. There is no way to avoid that. We really do not have fluff that can be removed without damaging our educational mission. The result of our choices will be damage and not something that can be justified. The product will not

be defendable which makes our *process* critically important. The decisions must be made with transparency, and with an openness to hear everyone's input. We also must aggressively search for other funding sources as we continue to push the state for the full and fair funding to support public education like they have long insisted they support. It is time for them to live up to their promises.

These collaborative agreements will be presented publicly at a board meeting

Agenda Item for 2X2 meeting

Background

- SRO and Crossing Guards in Pittsburg have a history of various funding sources
- Crossing guards were at one time funded by the city, if I remember correctly. They are now funded by the District alone.
- SRO services started with one officer, Officer Gargalikis, at the high school. This was funded by a variety of sources. Then, the district received a grant from state? Fed? Which allowed us to expand the SRO coverage until the grant ended. At that time, the District Board voted to continue the program through district funding. It has been extended and enlarged over time, all with district funding
- At the state level, CSBA studied district safety measures through the Delegate Assembly two years ago. At that time they found that SROs and Crossing Guards were funded in various ways. 25% were fully funded by districts, 50% were funded by both district and city, and 25% were funded by the city solely.

Mr. Woolridge – I would like to thank Mr. Haria and his staff for the Budget Subcommittee and for supporting us for the duration that we did. Also, tomorrow there is a Fund It Now Steering Committee facilitated by our county Superintendent to discuss the full education funding. I will be on that call along with other representatives from other districts. We will be building the campaign as to what \$1 more in education will bring. There will be a lot of events during that week. The first week in February will be the hosted campaign.

Mr. Smith - Prior to the break, we had a 2X2 meeting with the city. They are working on continuing to look for grants for safety so you will see a lot more of the beacon lights at crosswalks, you will also see that some of the bike lanes have been painted green, Pittsburg PD is continuing to have a presence around our schools. We also took part in the City of Pittsburg winter parade and I want to thank Student Services for being out there, they provided T-Shirts and encouraged parents to be active in their child's education. I would like to also thank Mr. Haria and Business Services for our Budget Subcommittee, we had quite a few recommendations come out of that meeting which we will review at an upcoming meeting.

Mr. Miller - I was also at the 2X2 meeting, and one of the things that the City wanted us to share with the community is that during our Census count it shows that Pittsburg is not counting all of its citizens. We all want to let our citizens know not to be afraid and register, because we are losing \$1,200 per person not registered. I would like to welcome back our teachers and staff. One other thing that I did before the break, I went to Los Medanos for their Project Learning, which was fantastic for me because I got to see the students share their work.

The contract with Rainbow Community Center is no longer in effect, and those students will now be supported by Vanessa Blum.

The Board asked for clarification on the services provided and discussed the increase request.

Dr. Canciamilla shared her appreciation for the Board's Student Board member, Ms. Gonzales, for her involvement and interest in what goes on in the District.

Dr. Schulze added that this project has been a priority area for the governance team but since the retirement of Mr. Palacios, this project was put on hold.

Mr. Arenivar agreed that this is needed as the District moves forward.

Dr. Canciamilla stated that she read the Goals, Needs and outcomes and wanted to clarify that the RFP states the preliminary schedule is released on January 9th, but the Board is not scheduled to take action until January 22nd.

Pittsburg High School the first in the nation to receive an autonomous vehicle. Unlike a Tesla, this vehicle has no steering wheel or brake pedal and is self-driven. The company donating this vehicle is called Local Motors in which the Contra Costa Transportation Authority was a huge part in making the connection towards this donation. There will be a Press release on January 23rd and in March, the vehicle will arrive which costs \$300k. Next year, an engineer will come once a month to work directly with students and teacher on the vehicle.

Dr. Schulze added that the company will be in the area which might allow students to possibly use this as a career pathway. She thanked Ms. Sasser for her work, ingenuity and her relationship building that allowed brought this to the District.
